The current cycle grant applications are made available March 1 and September 1, being due April 1 and October 1, respectively. Grants are read by 3 panels; government, education and non-profit. Panel members read and score each grant which is then averaged with the scores from other panel members. The entire panel then meets to discuss, review and determine awards.
